SKYLINE MOUNTAIN SPECIAL SERVICE DISTRICT RESOLUTION NO. 2020 -01

A RESOLUTION OF THE BOARD OF DIRECTORS OF THE SKYLINE MOUNTAIN SPECIAL SERVICE DISTRICT TO AUTHORIZE AND IMPLEMENT OF AN OUTDOOR WATER-USE POLICY

WHEREAS, Skyline Special Service District (the "District") owns and operates culinary and future secondary water systems; and,

WHEREAS, the District provides water service to customers and properties within the District, including customers and properties in Skyline Mountain Resort according to the "Water System Operating Agreement"; and

WHEREAS, the District finds the need to clarify and state its policy as to the outdoor use of water by its customers to ensure and promote responsible water-use; and

WHEREAS, The District desires to practice responsible water-use to minimize operational expense and added costs to its water-users,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE SKYLINE MOUNTAIN SPECIAL SERVICE DISTRICT:

SECTION 1. Authorization of the Policy. The Board of Directors does hereby approve this Outdoor Water-Use Policy ("**Policy**"), and authorizes the Chair to execute this Resolution and the Secretary to publish or post this Resolution as required by law.

SECTION 2. Definitions. "Outdoor Water-Use" is defined as all non-Domestic Use of water outside of a residence or cabin. Outdoor Water-Use includes irrigation of crops, lawns, trees, shrubs, landscaping, and other outside uses of water. "Domestic Use" is defined as use of culinary water within a home, cabin, or other building designed for human occupancy.

SECTION 3. Policy.

A. It is the Policy of the District that Outdoor Water-Use of water may occur in the area of the District that is designated as the "Full Time" residential area of the Skyline Mountain Resort. All such Outdoor Water-Use shall be metered and billed to the customer at rates established by the District.

B. In all other areas of the District, which are not within the Full Time residential area, Outdoor Water-Use, without prior written permission of the District, shall be limited to watering of non-native trees planted by the customer. All other Outdoor Water-Use is prohibited without the prior written consent of the District.

C. The District recommends and encourages all customers of the District to consider the use of xeriscaping, utilizing Utah-native plantings, and other water conserving landscape options to minimize the amount of water needed for outdoor use.

SECTION 4. Exceptions. This Policy only applies to water delivered by the District. This Policy does not apply to water provided by other entities, such as an irrigation company, or use of water under water rights not owned or delivered by the District.

SECTION 5. Effective Date. This Resolution will be effective immediately upon passage.
